The club will ensure to the best of its ability that no person who has committed an offence under one or more of the offences contained in Schedule 1 of the Children and Young Persons Act 1933 and other criminal offence which reasonably causes the club to believe that the person pose a risk of harm to a child or young person

The club officials will ensure that newly appointed officials, managers, coaches and volunteers complete a Football Association Personal Disclosure form and reference form.
